- Both the nominee (If the nominee or representative was unable to sign this document, please have them provide documentation (email or written letter) indicating their acceptance of this nomination) and the nominator must provide signatures endorsing the nomination and all of the information provided.
- The nominator and the nominee grant the New Brunswick Sports Hall of Fame the rights to use any of the provided materials for promotional, media, and broadcast purposes as related to its mandate.
- Nominations are eligible for a period of three years. If the nomination remains unsuccessful after these three years, the nominator will be contacted with further instructions relating to resubmission of the nomination.
